Assessment	<ul> <li>50% of ALES score, 20% of written exam grade, 10% of undergraduate or graduate GPA, 10% of foreign language score and 10% of interview score are taken into consideration.</li> <li>In order to evaluate the candidate's grades, the written exam score must be at least 50.</li> <li>In order for the candidate to be considered successful, the achievement score must be at least 65.</li> <li>A candidate who has not taken either the oral or the written exams is considered unsuccessful.</li> <li>If the scores are equal, the candidates with a high score from ALES or equivalent international exams are considered successful.</li> <li>If the candidates in the primarily announced list are not registered, the other candidates who have achieved the required success score but have not registered due to the quota can be registered between the dates specified in the form until the quota is filled.</li> <li>Undergraduate GPA is evaluated over 100. In transcripts that does not conform to this, an assessment will be made according to the conversion table of the Institute of Higher Education.</li> </ul>

• Documents received during the application will not be returned later. Documents brought without approval can be approved by our Institute if they are brought with their originals.
